

Requirements for nominations from the membership for the one director's term to expire at the Annual Meeting, Saturday, February 8th, 2025, are as follows:

EXCERPT FROM BYLAW ARTICLE 4.3

Nominees from the membership, for a position on the Board of Directors, shall be submitted to the nominating committee in writing, with the signatures of twenty-five (25) members in good standing, prior to January 10, 2025. SPCU nominating committee can then present the full slate of nominees to the membership at least thirty (30) days prior to the annual meeting. The nominees shall provide their qualifications, a biographical history, and a statement with their nomination giving the reason they would like to serve.

To apply for a loan, you must be a member of Savannah Postal Credit Union and you must have a minimum balance of \$150.00 in your savings account for the duration of the loan. For other qualifications, check with our Credit Union staff. The amount you may borrow depends on your annual income, credit history, and monthly debt ratio.
